

**Boomi AtomSphere Go**  
*Monthly Subscription with Auto-Renewal*

PLEASE READ THESE TERMS CAREFULLY BEFORE ACCEPTING THESE TERMS. BY PLACING AN ORDER FOR THE BOOMI SERVICES, YOU ACCEPT AND AGREE TO THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS, OR DO NOT HAVE THE AUTHORITY TO ACCEPT THESE TERMS, DO NOT SUBSCRIBE TO, ACCESS OR USE THE BOOMI SERVICES.

This Order is entered into between the entity you represent or, if you do not designate an entity, you individually (in each case, "you" or "your") and Boomi, LP ("Boomi") for you to purchase and Boomi to provide the following services for the term and at the prices stated below. Prices do not include any taxes that may be applicable. Any such taxes are your responsibility. Boomi competitors (as determined by Boomi) are not eligible to purchase AtomSphere Go.

**Free Introductory Period**

**Boomi is offering you a free introductory period ("FIP") to Boomi™ AtomSphere™ Go.** The FIP will continue for ninety (90) days from the date of this Order, unless Boomi cancels or extends your FIP, which Boomi may do in Boomi's sole discretion. Unless you cancel prior to the end of your FIP, you will be required to provide payment card information, and you will begin to incur the charges described below. The payment and billing terms in this Order will apply to you after the FIP. The FIP is governed by the terms for Evaluation Rights under the MSA. During the FIP, you may use Boomi Services for production purposes, and you will have the Support Services provided in this Order.

As a condition to your participation in the FIP, you agree to complete surveys and participate in interviews to provide your feedback regarding your experience, as reasonably requested by Boomi. Boomi may use your feedback to enhance its products and services. You grant Boomi a perpetual, irrevocable, royalty-free, worldwide right and license to use, reproduce, disclose, sublicense, sell, distribute, make derivative works of and otherwise exploit such feedback.

**Boomi will automatically renew your subscription using the payment method on file until you or Boomi choose to cancel this Order in accordance with the MSA.**

## ADDITIONAL TERMS

(1) The term of this Order begins on the date Boomi accepts your Order placed through the Online Portal (such date, the “Effective Date”). The Order is for a term equal to a Billing Period and will automatically renew for an additional Billing Period on the Monthly Renewal Date, unless the Order is canceled or terminated prior to the Monthly Renewal Date. You must cancel the Order prior to the Monthly Renewal Date in order to avoid paying the Subscription Fee for the next Billing Period. You may cancel this Order at any time through the Online Portal. Upon cancellation, you will be charged for any outstanding fees incurred (including the Usage Fee, if applicable).

(2) **Following the Monthly Renewal Date, you will be charged the Subscription Fee and the applicable Usage Fee (if any). Boomi will notify you of the date and amount of the charge. You authorize Boomi or its agent to charge the payment card on file on a recurring basis for all fees due under the Order, plus any applicable taxes.** The Subscription Fee is billed for the current Billing Period, and the Usage Fee is billed for the preceding Billing Period. Boomi will provide a confirmation or receipt of the charges. Boomi will provide billing and usage information in a format Boomi chooses, which may change from time to time.
