

COOKIE POLICY

Like many other websites iuro Rechtsanwälte GmbH (“we”, “us”, “our” or “**Prighter**”) uses so-called “cookies”. This Cookie Policy applies to the visitors of our website <https://prighter.com/>. Cookies are widely used to make websites work or improve their efficiency, as well as to provide information to the website owners. This Cookie Policy explains how we use cookies and why, but also on how you can decide which cookies you want to allow.

1. What are cookies

Cookies are small text files which are placed on your computer, tablet, smartphone or other devices (“devices”) when you visit a website and allow us to recognize your devices. These text files allow us to record certain pieces of information whenever you interact with our website, which we then use to optimize the performance of our website as well as to improve our products and services.

2. What cookies we use

We use different categories of cookies that serve different purposes:

Strictly Necessary Cookies (essential cookies)

Necessary cookies are essential for the website to function properly. They enable core functionality such as security, network management, and accessibility. Essential cookies will be provided by us. These types of cookies are always enabled. You may disable these by changing your browser settings, but this may affect the functionality of our website.

We process your Personal Data through strictly necessary cookies as it is necessary for the functionality and security of our website. It helps us preventing fraud, detect and mitigate potential security threats. This processing is based on our legitimate interest.

- Device information (ID, type of browser, operating system, language settings)

Performance Cookies (non-essential cookies)

Performance cookies allow us to collect information about the visitors of our website and how visitors use our website, e.g. which pages are the most and least popular, and how website visitors move around the website. Through these cookies we can measure and improve our performance of our website. This can also be done through analytical tools. These cookies will be provided by us or by a third party whose services are implemented on our site.

These cookies will only be placed if you give us your consent. You can withdraw your consent with effect for the future at any time via the cookie settings.

You can also prevent the storage of cookies generally by a corresponding setting of your browser software; however, please note that if you do this, you may not be able to fully use all the features of the website possible.

- Date and time of your visit or use of our website
- Referring (exit pages and URLs)
- Domain server
- Device information (type of browser, operating system, platform, and search engine used)
- Website activity (Number, duration and time of visits)
- Geolocation

Advertisement Cookies (non-essential cookies)

Advertisement cookies are mostly cookies from third party tools which are implemented on our website. Such cookies allow us to, e.g., deliver more relevant advertisements to you (customized advertising, retargeting, track your browser across other websites where enables and create a profile with your interest, etc.).

These cookies will only be set if you consent to it. You can withdraw your consent with effect for the future at any time via the cookie settings.

You can also prevent the storage of cookies generally by a corresponding setting of your browser software or not opting-in when you first visit our website. However, the ads you see will not be personalized and will therefore be less relevant for you.

- Website activity (duration, time of visits, pages visit)

- Search inquiries and history
- Demographic information
- Geolocation

Functional cookies help to perform certain functionalities like enabling enhanced functionality and personalization, such as remembering your preferences and settings. These cookies will be provided by us.

These cookies will only be placed if you give us your consent. You can withdraw your consent with effect for the future at any time via the cookie settings.

You can also prevent the storage of cookies generally by a corresponding setting of your browser software; however, please note that if you do this, you may not be able to fully use all the features of the website possible.

Personal Data processed

- User preferences (language, location)
- Session information (login in status, shopping cart items)
- Authentication data
