Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include, but is not limited to: <ul style="list-style-type: none"> ■ Social Security number and income ■ Account balances and payment history ■ Credit history and credit scores 		
How?	All the financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers personal information; the reasons Rocket Loans chooses to share; and whether you can limit this sharing.

What we do	
How does Rocket Loans protect my personal information ?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also train employees to comply with our privacy standards and policies, which are designed to protect consumer information
How does Rocket Loans collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> ■ Apply for loan or give us your contact information ■ Apply for financing or give us your income information ■ Provide employment information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes -- information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state laws.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account - unless you tell us otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ■ Some of our affiliates include companies with a "Rocket" name; financial companies such as Rocket Mortgage, LLC; nonfinancial companies such as Rocket Homes; and companies that have recently joined us: Redfin and Nationstar Mortgage LLC (formerly d/b/a Mr. Cooper).
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ■ Nonaffiliates we share with can include other financial services companies, lenders, insurance companies, retailers, or other consumer service providers.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ■ Our joint marketing partners include other financial services companies, lenders, or other consumer service providers.
Other Important Information	
For North Dakota and Vermont clients: We will not share information we collect about you with nonaffiliates, unless the law allows. For example, we may share information with your consent, to service your accounts, or under joint marketing agreements with other financial institutions. We will not share personal information about your creditworthiness with affiliates without your authorization, but we may share information about your transactions or experiences with our affiliates without your consent.
