**IP attachés** are intellectual property (IP) experts assigned to a U.S. embassy or consulate abroad. They serve an initial two-year limited appointment, which may be extended for up to three additional years.

## Role of an IP attaché

- Promotes and explains U.S. government IP policy overseas
- Advises U.S. government officials on foreign governments' IP systems
- Advocates for improvements to foreign countries' IP-related laws and regulations
- Conducts IP education and awareness programs for government officials and the public

## Helping U.S. stakeholders

IP attachés have assisted many U.S. industry associations and businesses in doing business abroad protecting and enforcing IP rights. IP-protected products can include:

- Software and semiconductors
- Pharmaceuticals
- Books and magazines
- Movies and television programs
- Musical works and recordings
- Electronic games
- Food and beverages
- Medical devices
- Automobiles and other manufactured products

## Job vacancies

Positions are announced through USAJobs.gov by the International Trade Administration, and are posted on the IP Attaché Program's webpage, [www.uspto.gov/ipattache](http://www.uspto.gov/ipattache). The announcements are for U.S. embassy and consulate-based positions that are titled Attorney-Adviser (Intellectual Property) or Commercial Officer (Intellectual Property).



IP attachés regularly speak with U.S. and foreign stakeholders about pressing IP issues.

## Locations and coverage

- **Belgium—Brussels:** European Union, Iceland, Norway, Liechtenstein, Switzerland, and United Kingdom
- **Brazil—Rio de Janeiro:** Argentina, Brazil, Paraguay, Uruguay, and Venezuela
- **China—Beijing:** National-level issues in China, plus Beijing and Shenyang, and Mongolia
- **China—Guangzhou:** Southern, Southwestern, and Southeastern China (including Hong Kong and Macao)
- **China—Shanghai:** Eastern and Central China, plus Taiwan
- **India—New Delhi:** South Asia
- **Mexico—Mexico City:** Mexico, Central America, and the Caribbean (including French Guiana, Guyana, and Suriname)
- **Peru—Lima:** Bolivia, Chile, Colombia, Ecuador, and Peru
- **South Africa—Johannesburg:** Sub-Saharan Africa
- **Switzerland—Geneva:** World Trade Organization and World Intellectual Property Organization
- **Thailand—Bangkok:** Southeast Asia
- **Ukraine—Kyiv:** Central Eurasia and the Western Balkans
- **United Arab Emirates—Abu Dhabi:** Middle East and North Africa
